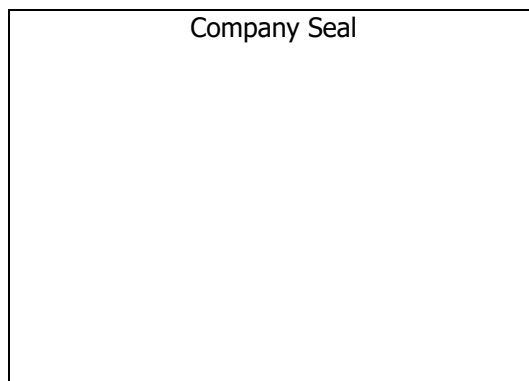

## **TERMINATION OF MEMBERSHIP**
